OTP Bank Plc. announces that – according to the Resolution No. 8/2024 of the Annual General Meeting on 26 April 2024, as a part of implementing the Bank's remuneration policy – on 6 May 2024 the Bank purchased 36,140 own shares at an average price of HUF 18,363 per share on the Budapest Stock Exchange, with the contribution of OTP Bank as investment service provider.
