OTP Bank Plc. announces that – according to the Resolution No. 8/2024 of the Annual General Meeting on 26 April 2024, as a part of implementing the Bank's remuneration policy – on 7 May 2024 the Bank purchased 97,879 own shares at an average price of HUF 18,545 per share on the Budapest Stock Exchange, with the contribution of OTP Bank as investment service provider.

Due to the transaction the stock of own shares owned by the OTP Group has been changed to 1,803,096 shares. The stock of own shares is 0.64%.
